COMMENTARY ON OPERATIONAL & BRANCH ACTIVITIES

Ongoing restrictions and concerns around meeting face-to-face meant that our other activities to members that would ordinarily have been organised with branches was largely delivered via online kai & korero sessions.

Our focus on supporting a successful conference during what was still a challenging time logistically meant our other capacity which would have normally been focused on supporting branch activities and other networking opportunities was put on hold so we could ensure a successful conference.

Our engagement with members, including earlier surveys following the 2021 online conference highlighted the real importance our members placed on kanohi ki te kanohi networking opportunities and was the driver behind our decision to support our volunteer conference committee.

2022-2023 also saw us explore if an Executive Director could further strengthen what ANZEA offers to members. Anne Bateman who was Treasurer on the 2019-2022 stepped down from her board role early to offer continuity as we transitioned to a new board, and acted as interim ED while we explored what a permanent ED role might look like.

While ultimately this proved to be financially unsustainable for the moment, Anne helped us establish a number of back-office improvements and forged other partnerships that are now starting to bare fruit - such as the discounted rates for professional development offered by Clear Horizon. We've delighted Anne has offered to rejoin the board as co-convenor to continue this work in a voluntary capacity.



Looking back at conference we are particularly proud of the ANZEA community, and all the NZ home grown presenters at the panel sessions and throughout the programme. It was great to see the range of evaluation activities taking place, the interest in the profession, the korero taking place, the inspiration and the wero laid down, the confidence in our Aotearoa NZ evaluation!

We were pleased that we could see the torch being passed forward as we honoured those who came before. Thanks for joining us, and we hope we will see you at the next conference.

FINANCIAL REPORT

ANZEA continues to grow and develop financially as an organisation in order to best serve its members, and financial activity is aligned with our strategic goals. The 2022 conference, while hugely successful overall, was ultimately run at a considerable loss and required ANZEA to use its reserves (which were approximately \$50,000) to cover. This also incurred substantial additional support from our ANZEA staff. A portion of the deficit is also due to phasing, as some of the conference income was received in prior year.


In 2022/23 we also had significant changes with the staffing and operations of the ANZEA to try and move to a more sustainable operational structure that reduced the demands on the Board (which has always been a working board). This investment also stabilised the organisation during a period of significant board changes.

Conference demands meant that all other revenue-generating activities such as setting up new PD or pursuing sponsorship and partnerships could not be actioned during the lead-up, delivery, and resolution of conference.

Since then, there has been significant activity by the team to start pursuing additional revenue-generating activity. Planned activities for the next year includes professional development and initiating work on the next conference to ensure we continue to be a viable and sustainable organisation into the future.

We ensure that our accounts are audited in line with applicable requirements associated with our charitable status.
